Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act." Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- 4. Interested bidders may obtain further information from **BUREAU OF FISHERIES AND AQUATIC RESOURCES XIII** and inspect the Bidding Documents at the address given below during office hours, Monday – Friday; 8:00AM – 5:00PM from *September 25, 2022 to October 17, 2022 not later than 9:00 AM.*

The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.

- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 9. Bid opening shall be on October 17, 2022, 10:00am at BFAR Caraga Regional Fisherfolk Training Center, Butuan City and/or via "Google Meet" application. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
