## INVITATION TO BID: Bid Reference No. 016-2023

### Supply and Delivery of Fishing Materials for National Bangus Development Program (NBDP) and PFO- Province of Dinagat Islands under Regular & Quick Response Fund (QRF)

1. The Bureau of Fisheries and Aquatic Resources Region XIII (BFAR XIII), through the Government Appropriations FY 2023 intends to apply the sum of **One Million Seven Hundred One Thousand Seven Hundred Eighty-two Pesos and 60/100 centavos only (₱1,701,782.60)** being the Approved Budget for the Contract (ABC) to payments under the contract for the Project, "Supply and Delivery of Fishing Materials for National Bangus Development Program (NBDP) and PFO- Province of Dinagat Islands under Regular & Quick Response Fund (QRF)". Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The BFAR XIII now invites bids for Goods indicated above. Delivery of the Goods is required within **45 calendar days**. Bidders should have completed, within **5 years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizen/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

A complete set of Bidding Documents may be acquired by interested Bidders on **August 30, 2023 – September 18, 2023** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount stated above. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.
6. The Bureau of Fisheries and Aquatic Resources (BFAR) XIII will hold a Pre-Bid Conference on **September 6, 2023 ; 2:00PM** and/or through video conferencing, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through i) manual submission at the office address indicated below, (ii) online or electronic submission as indicated below, or (iii) both} on or before **August 18, 2023 at 11:00 AM**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on **August 18, 2023; 11:00 AM** at BFAR Caraga Regional Fisherfolk Training Center, Butuan City and/or via “Google Meet” application. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
10. Bidders are advised to submit their bids in accordance with the BFAR XIII BAC procedure for online bidding as well as for the printed as provided under ITB Clause 10 and Clause 11.

The Bureau of Fisheries and Aquatic Resources (BFAR) XIII reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
