 The Bureau of Fisheries and Aquatic Resources Region XIII (BFAR XIII), through the Government Appropriations FY 2024 intends to apply the sum of One Million Four Hundred Eighty-one Thousand One Hundred Forty-nine Pesos and 25/100 centavos Only (£1,481,149.25) being the Approved Budget for the Contract (ABC) to payments under the contract for the Project, "Re-bidding for the Supply and Delivery of 65 units Marine Engine for the Fiberglass Reinforced Plastic (FRP) Motorized Boats for distribution in Caraga under Regular and SAAD Program CY 2024 (Lot 1)". Bids received in excess of the ABC shall be automatically rejected at bid opening.

- The BFAR XIII now invites bids for Goods indicated above. Delivery of the Goods is required within
 45 Calendar Days
 Bidders should have completed, within 5 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizen/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 2. Prospective Bidders may obtain further information from BFAR XIII Bids and Awards Committee (BAC) Secretariat or FishCORAL Procurement Officer and inspect the Bidding Documents at the address given below during office hours from 8:00 a.m. to 5:00 p.m.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on March 28, 2024 April 18, 2024 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount stated above. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.
- 6. The Bureau of Fisheries and Aquatic Resources (BFAR) XIII will hold a Pre-Bid Conference on **April 5, 2024; 4:00PM** and/or through video conferencing, which shall be open to prospective bidders.
- Bids must be duly received by the BAC Secretariat through i) manual submission at the office address indicated below, (ii) online or electronic submission as indicated below, or (iii) both} on or before <u>April 18, 2024; 2:30PM</u>. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on <u>April 18, 2024; 2:30PM</u> at BFAR Caraga Regional Fisherfolk Training Center, Butuan City and/or via "Google Meet" application. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. Bidders are advised to submit their bids in accordance with the BFAR XIII BAC procedure for online bidding as well as for the printed as provided under ITB Clause 10 and Clause 11.

The Bureau of Fisheries and Aquatic Resources (BFAR) XIII reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
