## **NOTICE OF RESOLUTION DENYING REQUEST FOR RECONSIDERATION**

**(Supply & Delivery of Hardware Materials & Electrical Supplies for Various Fisheries Project  
of BFAR Caraga CY 2024)**

April 24, 2024

In view of your Request for Reconsideration of your Disqualification which this committee received on April 19, 2024, please be informed that, after careful deliberation and thorough discussion, with regrets, the Committee hereby resolved to **DENY** your **REQUEST** for **RECONSIDERATION**.

SMART MOVE BUILDERS through Ms. Raufa B. Hasan, filed its Motion for Reconsideration on April 19, 2024, which was received by the Committee on the same date.

Reading of the arguments, taking into consideration, there was no Statement of All Ongoing Government & Private Contracts including contracts awarded but not yet started attached upon opening the Eligibility and Technical Envelope of the abovementioned bidder.

Under Section 23 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, the Government Reform Act, that during the Eligibility Screening, the submission of the eligibility documents enumerated in Section 23. 1 is a mandatory requirement that must be complied with by prospective bidders, such that failure to submit any of the documents or the submission of an otherwise incomplete or patently insufficient document, will disqualify the bidder based on the non-discretionary "pass/fail" criterion as stated in the Instructions to Bidders under Section 30.1 of the 2016 IRR.

As stated in Section 6.2.a. of the Instruction to Bidders of the Philippine Bidding Documents, the Bidder is responsible in having taken steps to carefully examine all of the Bidding Documents, and such statement was indicated in the Omnibus Sworn Statement to be submitted in the form prescribed in Section IX Bidding Forms as required in ITB Clause 12.1 (b)(iii).

Further, Section 55 states, the bidder shall not be allowed to submit additional documents to correct any defects in the bid submitted thus we cannot accept the additional document submitted by the bidder.

Premises considered, Motion for Reconsideration is hereby **DENIED**.
