## **NOTICE FOR NEGOTIATED PROCUREMENT**

### **Supply & Delivery of Hardware Materials and Electrical Supplies for Various Fisheries Project of BFAR Caraga CY 2024**

1. In view of two (2) failed public biddings, the **Bureau of Fisheries and Aquatic Resources Region XIII- Bids and Awards Committee (BFAR XIII-BAC)**, through the Government Appropriations FY 2023 invites interested bidders to participate in the negotiation for the **“Supply & Delivery of Hardware Materials and Electrical Supplies for Various Fisheries Project of BFAR Caraga CY 2024”**, in accordance with Section 53.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184, otherwise known as the “Government Procurement Reform Act.” The BFAR Caraga, through the Government Appropriations FY 2023 intends to apply the sum of **One Million One Hundred Ninety Thousand One Hundred Forty-Three Pesos Only (₱1,190,143.00)** being the Approved Budget for the Contract (ABC).

2. The BFAR XIII-BAC will hold a Negotiation with interested bidders on **June 18, 2024; 2:00pm** at the **BFAR Caraga Regional Fisherfolk Training Center, Sitio Tawilon, Brgy. Ambago, Butuan City.**
3. The Eligibility Documents, Technical Proposal and Best and Final Offer (Negotiation Documents) stated in the checklist shall be submitted in one (1) original and one (1) duplicate copy on or before **June 25, 2024; 9:30am** at the **BFAR Caraga Regional Fisherfolk Training Center, Sitio Tawilon, Brgy. Ambago, Butuan City.**

The BAC shall conduct the meeting for the opening of the negotiation documents on **June 25, 2024; 10:00am.** Best and final offers received in excess of the ABC shall be automatically rejected.

Bidding is restricted to Filipino citizens/sole proprietorship, cooperatives, partnerships or organizations with at least sixty (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

The Bids and Awards Committee will invite and engage in negotiations with a sufficient number of suppliers (at least three [3] suppliers of good standing) to ensure effective competition. The selection of the successful offer shall be based on the best and final offer that will be submitted on a specified date, which should meet the BFAR XIII minimum technical requirements and does not exceed the ABC.

4. Within one (1) calendar day from notice, the bidder whose submission is determined as the Lowest Calculated Quotation shall submit its Quarterly Income Tax Returns for 1<sup>st</sup> Quarter of CY 2024 and 1<sup>st</sup> Quarter of CY 2024 (Form 1702Q) and its July to December 2023 VAT returns (Form 2550M and 2550Q) or Percentage Tax Return (Form 2551M), with proofs of payment.
5. Interested bidders may obtain further information from the BFAR XIII-BAC Secretariat and inspect the Bidding Documents at the address given below during office hours from 9:00 am to 4:00pm.
6. Bidders are advised to submit their bids in accordance with the BFAR XIII BAC procedure for online bidding as well as for the printed as provided under ITB Clause 10 and Clause 11.
7. The Bureau of Fisheries and Aquatic Resources (BFAR) XIII reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
