2. The **BUREAU OF FISHERIES AND AQUATIC RESOURCES XIII** now invites bids for **Construction of Various Infrastructure Projects of BFAR Caraga CY 2024** which includes civil works and general items. Completion of the Works is required **within Lot 75 & 20 calendar days.** Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in in Section III. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from **BUREAU OF FISHERIES AND AQUATIC RESOURCES XIII** and inspect the Bidding Documents at the address given below during office hours, Monday – Friday; 8:00AM – 5:00PM from **October 8-October 28, 2024**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **October 8-October 28, 2024**, from given address and website/s below and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the Government Procurement Policy Board (GPPB), in the amount of **₱1,000.00**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.
6. The **BUREAU OF FISHERIES AND AQUATIC RESOURCES XIII** will hold a Pre-Bid Conference on **October 16, 2024, 10:00am** at **BBMB Office, Sitio Tawilon, Brgy. Ambago Butuan City**, and/or via **“Google Meet” application**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through i) manual submission at the office address indicated below, (ii) online or electronic submission as indicated below, or (iii) both} on or before **October 28, 2024; 3:00pm**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 16**.
9. Bid opening shall be on **October 28, 2024; 3:00pm** at **BFAR Caraga Regional Fisherfolk Training Center, Butuan City** and/or via **“Google Meet” application**. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
10. Bidders are advised to submit their bids in accordance with the BFAR XIII BAC procedure for online bidding as well as for the printed as provided under ITB Clause 10 and Clause 11.
11. The Bureau of Fisheries and Aquatic Resources (BFAR) XIII reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
